Notes from the Committee Chair



Welcome to the winter 2024 issue of Assurance Matters. Highlighted in this issue are the OHAS subscription and NSF audit fees for next year. Having held both throughout 2024, small increases are having to be made to cover inflationary increases.

To assist members

with their storage and use of approved plant protection products, the latest news about product withdrawals is also included. Product revocations are currently happening regularly at both EU and GB level, so to enable products to be used up or disposed of in an approved manner, it's useful to know in advance key expiry dates.

Developments are also underway to create consistent carbon reporting across the supply chain, in both broad agricultural/horticultural terms, and specifically regarding the production of ornamentals. This development is to be welcomed in that there are numerous carbon footprinting tool kits on the market, but few, if any, are relevant to the production of ornamental crops and none have universal acceptance throughout the supply chain. A relevant, accepted tool kit would help to clarify the way forward with carbon reporting, and underpin both nursery/packhouse and supply chain reduction measures.

Finally, there is a brief reminder about which plant species are covered by the CITES Convention, in place to prevent the illegal harvesting of plants from the environment.

May I take this opportunity to wish all our members a Merry Christmas and prosperous New Year.

Scheme subscription and audit costs for 2025

The OHAS subscription rates (for non-HTA members) for 2025 will increase by 3%, having been held static throughout 2024. The subscriptions collected are essential as they cover the cost of the Scheme, the development of the various Standards and the benchmarking to GlobalGAP. The new rates are presented on the following page and are based on annual turnover. To fall into line with HTA subscription collection procedures, validation of business annual turnover will now occur every two years to ensure businesses are placed into the correct band. As per original applications to OHAS, turnovers must be stated and verified with an accountant stamp. Letters explaining this will be sent out to members in the new year.

Auditor expenses including, but not limited to the following will be charged onto the client - accommodation, mileage, flights and subsistence.

If an audit is cancelled, all incurred travel reservation and costs that cannot be cancelled, will be recharged to the client. If the audit is cancelled within two weeks of the audit date, the client may be charged 30% of the audit fee at the discretion of NSF. For additional sites, the above fee assumes the location is in the same country and no further than 30 miles away.

Crop protection news – product withdrawals

Managing the content inventory of pesticide stores can be a complex task because of the sheer number of product approval changes and revocations over a 12-month period. To assist growers with this task, below is a summary of recent and upcoming GB revocations impacting key products used in the ornamentals industry.

• Stocks of Systhane 20 EW (myclobutanil) and Consul, Impact, and Topguard (flutriafol) **should now have been used up.**

- Stocks of Dynamec (abamectin) and Curzate and Dithane (mancozeb) need to be used up by October and November 2025 respectively.
- Stocks of Explicit, Rumo, and Steward (indoxacarb) need using by February 2026.

The following products have also been commercially withdrawn - Applaud 25 (buprofezin), Azatin (azadirachtin), and Nissorun SC (hexythiazox). Looking ahead, the following key products have been withdrawn, or face withdrawal, in the EU, which indicates their imminent withdrawal in GB:


- Apollo 50 SC (clofentezine)
- Batavia (Movento) (spirotetramat)
- Debut (triflusulfuron-methyl)
- Dual Gold (s-metolachlor)
- Frupica SC (mepanipyrim)
- Paraat (dimethomorph)
- Reflect (isopyrazam)
- Zorvec Enadvia (benthiavalicarb + oxathiapiprolin)

Product carbon footprinting projects

There have been updates on two projects helping to develop carbon life assessments for horticultural products. Firstly, several UK retailers are involved in a project run by the British Retail Consortium in partnership with Mondra and have developed and launched a platform to tackle the challenge of consistent carbon reporting across the supply chain, and enable retailers to see the footprint of an individual food item, such as a sandwich or a pint of milk. They are currently focusing on food but will soon be able to move to other fresh produce such as cut flowers and potted plants. The HTA is actively involved in the coalition, as are some producers. They are also exploring options around landbased carbon removals, and whether these can be achieved within the supply chain.

The second project is called **FloriPEFCR** (Flori Product Environmental Footprint Category Rules). FloriPEFCR was developed by Wageningen University and Research, and a Technical Secretariat involving Royal FloraHolland and other organisations. It consists of calculation rules for each category to calculate a product's footprint and specifically covers cut flower and pot plants. The product footprint category rules were ratified in February, and since then development of carbon footprinting tool kits have been underway. There are now two benchmarked tool kits approved for use, the **HortiFootprint Calculator** from MPS/LetsGrow. com and the **FloriFootprint Tool** from Greenhouse Sustainability.

The HTA is linking up the two projects, and Mondra are now investigating how they can incorporate and comply with FloriPEFCR in the future.



CITES permits

If you import species covered under the CITES Convention, then your exporter must have an export permit, and you must have an import permit for each consignment. Information that must be provided to APHA and Defra includes the origin of the species being imported to ensure that endangered species are not being taken from the wild illegally.

Permits can take up to 30 days to arrive and the paperwork must be physically stamped on entry to GB by the haulier at a CITES office (located at most ports).

Species covered by CITES include:

- Aloes (except *Aloe vera*)
- Euphorbiaceae (succulent varieties)
- Dionaea muscipula
- Nepenthaceae
- Sarraceniaceae
- Pachypodium
- Galanthus
- Sternbergia
- Cyathea
- Beaucarnea
- Cycadaceae
- Araucaria araucana
