






UK Government Ambitions

EU Ambitions

1 special area to target



- A Youth Mobility Scheme to allow 18-30 year olds to travel and work between the UK and EU.
 - "Youth Experience Scheme"

Where were we before the EU-UK Strategic Partnership was announced

- Border Targeting Operating Model in operation
- Checks at the borders from 30/4/2025
- Phytosanitary Certificates (import & export)
- Separate Plant Passporting regime
- Reduction in exports
- Separate plant variety rights registration
- Separate seed testing & marketing requirements
- Separate chemical / PPP regimes





What is the EU-UK Strategic Partnership

What is the SPS common area and what will be negotiated?

19 May deal agreed a common Sanitary Phytosanitary area

- Includes plant health and includes animals & animal products (agri-food)
- "dynamic alignment" with EU i.e. UK will follow EU plant health rules
- Checks & certification removed
- Closer EU-UK collaboration (Govt to Govt)
- Access to EU's agencies, systems and databases
- National measures reintroduced?
- EU plant passporting system?

Possible pitfalls & challenges

- Issues at the border continue
- Trade GB-NI remains difficult
- EU regulatory divergence, since Brexit & ongoing
- Current HTA activities what will happen e.g.
 - Electronic plant passporting pilot group
 - Authorised Operator Status pilot
 - UK Plant Health Fees increases when? If?
 - Submitting HRP dossiers to EFSA ceased
- How will APHA redeploy resource currently at BCPs
- How have other organisations / sectors welcomed the deal?







What's next

For the SPS deal....



- Negotiations will commence very shortly
 - Expected to take 6-9 months
 - Then 12 months to implement
 - Total 18 months estimated



- EU recommendation on SPS & ETS published last week
- HTA continue in Domestic Advisory Group
- HTA continue international engagement programme, working with other trade associations and representatives around EU
- HTA will continue to work on current border issues
- Please remain compliant, and encourage suppliers to do so too
- HTA will represent members interests
