CITES introduction

 CITES = Convention on International Trade in Endangered Species of Wild Fauna and Flora

https://cites.org/eng

185 signatory Parties

Its aim is to ensure that international trade in specimens of wild animals and plants does not threaten the survival of the species.



CITES requirements

3 Appendices (translated into 4 Annexes in EU and UK)

Species+ (speciesplus.net)

- Trade controls through an export–import permits system:
 - Annex A & Annex B: (re-)export + import permits
 - Annex C: (re-)export permit/cert. of origin + import notification
 - Annex D: import notification
- Main assessments: Legal Acquisition Finding (LAF) and Non-Detriment Finding (NDF)





- Most orchids c.29,000 spp.
- Most cacti c.1,500 spp.
- All aloes (except art. prop. Aloe vera) c.600 spp.
- All Sarracenia spp. c.29 spp.
- Dionaea muscipula
- Tropical hardwoods, e.g. mahoganies (e.g.
 Swietenia macrophylla) and rosewoods (Dalbergia/ Guibourita spp.)



Overview

This consultation invites views on proposed regulatory reforms to the CITES implementing framework in the UK.

The Convention on International Trade in Endangered Species of Wild Fauna and Flora ("CITES") is an international agreement that aims to ensure that international trade in specimens of wild animals and plants is conducted legally and does not threaten the survival of the species. A key part of this is achieved through the issuing of permits for the import, (re-)export and introduction from the sea of species listed on the CITES Appendices.

CITES legislative reform

1. Proposals to amend CITES assimilated legislation

Better targeting of CITES controls

- Article 10 certificates (commercial use certificates)
- Import permits for Annex B specimens
- Semi-complete permits
- Annex D
- Travelling Exhibition Certificates
- Accommodation and care considerations within the WTRs

Strengthening conservation outcomes

- Greater use of civil sanctions to address enforcement gaps
- Strengthen controls in place for Schedule 4 listed bird species



CITES legislative reform

- 1. Proposals to amend CITES assimilated legislation (cont.)
- Article 60 certificates
- Provisions to better address smuggling post-import
- Registration of facilities that captive breed Appendix I species for commercial purposes in line with CITES Resolution 12.1
- UK domestic stricter measures
- Revising the criteria for exceptional Port of Entry use

CITES implementation

- Amendments to the implementation of Appendix III (Annex C)
- Suspensions Regulation (EC Reg 1587/2019)
- Grounds for application refusal

Amendments to CITES Appendices

Chilean palm (Jubaea chilensis) – Include in Appendix I

Ponytail palm (*Beaucarnea glassiana & B. hookeri*) – Include in Appendix II

Avonia quinaria – Transfer from Appendix II to Appendix I

Cycad Spurge (*Euphorbia bupleurifolia*) – Transfer from Appendix II to Appendix I

Aloes (Aloe bergeriana, A. jeppeae, A. subspicata & A. welwitschia) — Include in Aloe genus listing (previously considered part of non-listed *Chortolirion* genus)
